- ◆ **Elizabeth “Libbie” Bragg** (2008-2009 Fellow) presented on “Gaps in the Dementia Care Workforce: Research Update and Data Needs” at The National Academies of Sciences, Engineering, and Medicine Committee on Population (CPOP) Semi-Annual Meeting Seminar on May 23, 2019. Libbie is also a Member of the Dementia Summit Workforce Stakeholder Workgroup, and is charged with developing 10 workforce recommendations to be presented at the National Research Summit on Care and Services on March 24-25, 2020 at the Natcher Center, National Institutes of Health campus.
- ◆ **Jennifer Wong** (2018-2019 Fellow) helped organize and presented at an interdisciplinary meeting on Opioids and Older Adults at Public Health-Seattle and King County on September 30, 2019. The meeting aimed to raise awareness

of the current state of opioids and seniors through data sharing, hear from stakeholders about the problem and possible solutions, develop and strengthen relationships between sectors, and consider next steps. Dr. Wong presented data from King County describing seniors' experiences with IV drug use and opioid-related deaths and suicides to show similar trends that have been reported on a national level.

- During his fellowship year in the Office of the Speaker of the U.S. House of Representatives, Congresswoman Nancy Pelosi, **Steven Starks** (2018-2019 Fellow) worked on H.R. 3 (Lower Drug Costs Now Act), legislation that would establish a negotiation program to protect the Medicare program, its enrollees, and all Americans from excessive prescription drug costs.

Steven will return to Texas to join as inaugural faculty in the department of Clinical Services at the new University of Houston College of Medicine. The college will enroll its first class in fall 2020. In addition to this new role in teaching, curriculum development and community partnerships, he will provide psychiatric care at the federally qualified health center partner of the college, Lone Star Circle of Care. He plans to incorporate his newfound understanding of the legislative process into educational curricula for healthcare professionals and to focus his attention on policies that improve workforce shortage issues.

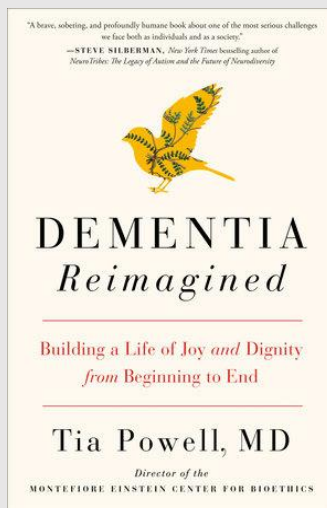
### *Awards and Recognition*

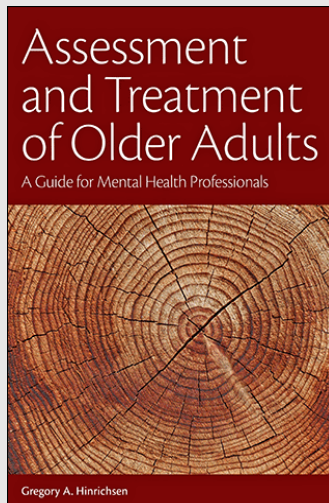

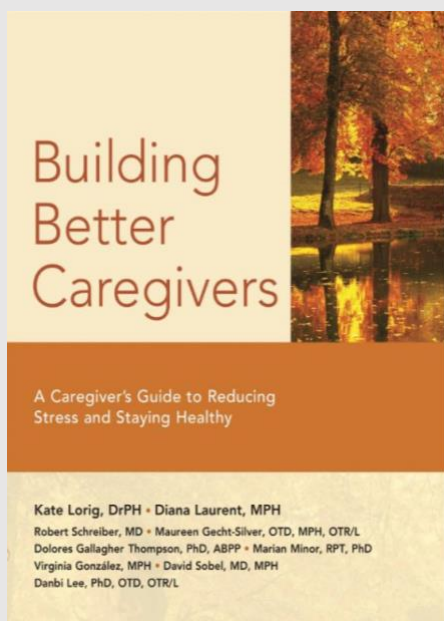
