In the latest of a series of Commonwealth Fund case studies on models of care for high-need, high-cost patients, Douglas McCarthy, Lisa Waugh, and Paige Nong provide an in-depth overview of the Geriatric Resources for Assessment and Care of Elders (GRACE) model and look at the experiences of four diverse sites that replicated it. Developed by geriatrician Steven Counsell, M.D. (2009-2010 Fellow) at the Indiana University School of Medicine, the model stands out for its integrated approach to engaging patients as partners in identifying and achieving their health goals at home.
