#### Jennifer Wolff (2013-2014 Fellow)

The study concluded that home health patients use the patient portal to perform care management tasks and access clinical information.
  - Chanee Fabius, Jennifer Wolff, and Vicki Freedman published <u>an invited commentary in JAMA Internal</u> <u>Medicine</u> about family and unpaid caregivers being the primary source of assistance to older adults with care needs who are living in the community, as well as paid services and supports, which may augment help from family and unpaid caregivers.
  - Lisa Reider, Jason Falvey, Safiyyah Okoye, Jennifer Wolff, and Joseph Levy published <u>a study in *Injury*</u> which found that more than 3 million older adults in the U.S. seek hospital care for fall injuries annually. The \$20 billion in annual acute

treatment costs attributed to fall injury indicate an urgent need to implement evidence-based fall prevention interventions and underscores the importance of newlylaunched ED-based fall prevention efforts and investments in geriatric emergency departments.
